  - Information dissemination and technical assistance



- Using a combination of approaches
- Opportunity to address inequality in health care at the same time

### A View from Five States

- Analyzed legislation in five states (MA, WA, CA, IL, & PA)
- States are addressing the benchmarks in various ways:

#### Access to health care

- Creating mechanisms to promote diversity among health are professionals (MA, IL, PA)
- Improving & streamlining enrollment procedures (MA and IL)
- Evaluating outreach & enrollment procedures (MA, WA, CA, IL, PA)

#### Quality of care

Collecting data on race, ethnicity, and primary language (MA, WA, CA, IL, PA) and publicly reporting info (MA, CA)

# A View from Five States (cont.)

States are addressing the benchmarks in various ways:

#### Patient empowerment

 Conducting a community health worker study to determine effectiveness in reducing racial and ethnic health disparities (MA)

#### Health care infrastructure

- Supporting safety net institutions such as community health centers (MA, WA, IL)
- Providing incentives for health care professional to practice in underserved areas (IL)

# A View from Five States (cont.)

States are addressing the benchmarks in various ways:

#### Policy infrastructure

- Utilizing community health planning to better align resources and need (WA, IL)
- Creating a Health Disparities Council charged with making recommendations on workforce diversity issues, monitoring disease rates, and addressing some SDH (MA)

#### Social and community determinants of health

 Coordinating relevant state agencies to address social and behavioral determinants

### A View from Five States

#### States are not:

- Assessing how affordability policies & individual mandates affect uninsured populations
- providing explicit training and reimbursement for CHWs
- developing patient education programs that are tailored to the needs of communities of color
- reducing geographic inequity in the distribution of health care services
- Incorporating use of health impact assessments (exception: WA)
- strengthening state offices of minority health

# Opportunities for Advocates

- Actively follow the implementation of new health care expansion laws
- Ride the health care reform wave
- Build bridges, knock down silos
- Recognize appropriate vehicles, create new ones

# Opportunities for Policymakers

- Make universal health care a core goal and cover everyone
- Assess how states policies to expand coverage affect currently underserved groups
- Be an agent for change
- Reach for low-hanging fruit
