#### **U.S. SENATE**



### "American Jobs Act of 2011" (S. 1660)

Created to extend the payroll tax cut to keep money in the pockets of hardworking families and to create job opportunities for the unemployed, low-income individuals, and young people on projects that improve local communities.



Members with this icon next to their names voted against this bill which is contrary to homeowner, consumer, and worker protections.



# Confirmation of Richard Cordray of Ohio as Director of the Consumer Financial Protection Bureau (CFPB)

Nominated to ensure strong leadership and oversight of the CFPB—the new bureau devoted entirely to looking out for consumers' rights.



Members with this icon next to their names voted against this confirmation which is contrary to homeowner, consumer, and worker protections.

#### **U.S. HOUSE OF REPRESENTATIVES**



### Amendment to the Dodd-Frank Wall Street Reform and Consumer Protection Act

Created to dilute the strength of the CFPB by replacing its director position with a committee, giving predatory lenders and scam artists the upper hand. Congressional members with this icon next to their names stood up for consumer protections by voting **against** this amendment.



Members with this icon next to their names voted for this bill and thus contrary to homeowner, consumer, and worker protections.



### **NSP Termination Act (H.R. 861)**

Created to zero out a final round of much-needed funding for the Neighborhood Stabilization Program (NSP) and then to terminate the program in the midst of the enduring foreclosure crisis. Congressional members with this icon next to their names stood up for homeowners by voting against this bill.
