# Joint Statement of America's Health Centers Opposing Changes to Public Charge

WASHINGTON, August 12, 2019 — The Administration has released the final regulation that expands the definition of "public charge" and puts the health and well-being of immigrant families at risk. Implementation of the final Public Charge rule will start 60-days after the official release, which is currently scheduled for August 14, 2019.

In response, the undersigned organizations continue to stand united in opposition to the final rule. As representatives of America's health centers and the 29 million patients they serve, we work together to ensure access to quality and affordable health care for all in need, regardless of immigration status. The health center model and mission is to ensure access to affordable health care so that all individuals can contribute to their communities and reach their full potential. The final Public Charge rule is in direct contrast to this mission of America's health centers.
